In case party b is found to have dumped the waste or refuse at will, leading to charge filed by the Environmental Protection Bureau or the like that results in fine or suspension of work, party b shall be held fully responsible or responsible for compensation for the total loss party b or party a thus incurred during this period while party a shall be held totally harmless. -. Enter & depart from work site:

厂区进出规定

- 1. In and out of the plant area, all workers are required to wear the work ID or temporary ID while workers hired by the contractor under the plant affair system shall wear vest or company uniform. 进入厂区内一律配戴工作证或临时证,参照行政部门"公司安保政策"相关规定执行。属厂务系统之承揽商一律穿识别背心或公司制服。
- 2. When entering the clean room, a prior application must be filed with the purchasing department and observation to the clean room rules is a must. All workers hired by the contractor shall wear the arm ID badge

During the hot work period, each contractor or vendor shall make a conspicuous display in the hot work site of the work application form approved, and shall designate a watcher and a supervisor for such hot work.
